Notice of the Status of Buyback of Company Shares

At the Board of Directors meeting held on July 30, 2015, FUJIFILM Holdings Corporation (the "Company") resolved to buy back the Company's shares, based on the stipulations of paragraph 3, Article 165, of Japan's Companies Act, as interpreted in the light of Article 156 of the Companies Act.
